Tiny Yet Mighty Initiative at the Spanish Town Hospital

The Spanish Town Hospital's (STH) pre-graduate programme for premature babies, 'Tiny Yet Mighty', is a powerful initiative. Mrs. Stacy-Ann Burnett-Brissett, Certified Registered Neonatal Nurse, Founder, Director of Tiny Yet Mighty, said that this project was inspired by God to celebrate the life of a premature neonate, which began in 2017 and has since expanded. This approach has been implemented by other Neonatal Intensive Care Units (NICUs) in Jamaica.

Mrs. Burnett-Brissett explained that it is the only graduation programme of its kind in the world. Babies aged 38 weeks and under received a diploma when they were discharged from the NICUs at STH. The management of the STH expressed highest commendations to the medical team for the exceptional work that they have been doing at the hospital.



Jamaica to Benefit from Blood Donation Software



Jamaica will now have the benefit of a new software platform, e-Delphyn Donor, which is to streamline and enhance blood donation and management islandwide.

The announcement was made by Mr. Dunstan Bryan, Permanent Secretary (PS) in the Ministry of Health and Wellness, who spoke on Friday, June 14, 2024, at the World Blood Donor Day recognition ceremony. The ceremony was hosted at the offices of the National Blood Transfusion Service in Kingston under the theme '20 Years of Celebrating Giving: Thank you, Blood Donors'.

The software offers donor registration and management; blood drive scheduling and organisation; as well as donor health screening and deferral tracking. These are in addition to blood typing and cross-matching; inventory management for blood products; reporting and analytics for blood donation data; and integration with laboratory and hospital systems.

Through the use of the e-Delphyn, blood banks and transfusion services can streamline their operations, reduce errors, and improve the overall quality of the blood supply.

World Blood Donor Day is observed annually on June 14 to raise global awareness of the need for safe blood and blood products for transfusion. It also serves to highlight and to celebrate the invaluable contribution of voluntary, unpaid blood donors to national health systems.



\$1M Worth of Sanitization Equipment from Parkland Industrial Company Limited

The SERHA received sanitization equipment to the tune of JA\$1 million from Parkland Industrial Company Limited, a leading industrial packaging company in Jamaica. The donation included Touch Free Soap/Gel Dispensers. The handover event took place on Monday, June 3, 2024, at the Victoria Jubilee Hospital (VJH).

In his address at the event, Mr. Richard Reid, the Business Development Manager of Parkland Industrial Company Limited, emphasised the company's dedication to exceeding expectations by delivering superior products and services. He highlighted the critical role of proper sanitization in healthcare, especially during challenging times, stating:

The sanitisation equipment will be distributed by SERHA to the hospitals in the region, namely the Victoria Jubilee Hospital, the Kingston Public Hospital, the Bustamante Children's Hospital, the Princess Margaret Hospital, and the Spanish Town Hospital.

Dialysis Machines in SERHA's Hospitals to Improve Healthcare

SERHA takes note of the Jamaica Gleaner's Letter of the Day published on Friday, June 28, 2024, titled "Lack of dialysis machines hitting kidney disease patients hard." Between the period of September 2022 and January 2023, SERHA acquired thirty-three (33)haemodialysis machines, which have greatly bolstered the region's and, by extension, the nation's ability to provide essential treatment to patients with kidney disease. The details of the acquisition are as follows: On September 12, 2022, the Spanish Town Hospital (STH) received a donation of ten refurbished haemodialysis machines, valued at approximately \$28 Million Jamaican Dollars, from Renal Dynamics, a Florida-based company. STH was at that time also the recipient of a \$12 Million Jamaican Dollars donation from the National Health Fund and Transport Authority for three brand-new machines.

Additionally, in January 2023, SERHA purchased ten dialysis machines for STH at a cost of JA\$28,875,800, and another ten for the Kingston Public Hospital (KPH) at a cost of US\$185,100.00. There are, therefore, a total of 18 machines in operation at STH. Five of the ten refurbished machines that STH had received had been transferred to KPH so the total at KPH is now 22 operational machines.

According to Dr. Jacqueline Wright-James, Senior Medical Officer, STH, the hemodialysis unit at STH treats patients ranging in age from 13 to 81 years. On average, the unit performs over 6,500 dialysis sessions per year. The number of patients on the waiting list has significantly fallen to 122 from a high of 291 since 2023. The team is actively exploring strategies to increase the number of sessions and thus reduce the numbers waiting for this life-sustaining intervention.

Mr. Errol Greene, Regional Director, SERHA, stated that these machines have improved healthcare for patients with kidney disease. The standard of care for renal patients has improved tremendously, providing dialysis treatment to 62 patients twice weekly at STH and 72 patients twice weekly at KPH. He further commented that there are plans to expand dialysis services at the Center of Excellence at St. Joseph's Hospital to deal with the increasing number of emergency sessions per month.

VJH Successfully Conducting Four In-Utero Transfusions



Congratulations to the outstanding staff at the Victoria Jubilee Hospital for successfully conducting four in utero transfusions.

The management of SERHA congratulates the outstanding staff at the Victoria Jubilee Hospital (VJH) for successfully conducting four in utero transfusions to date since 2017, the last of which was done in June 2024. The ground-breaking procedure involves the direct transfusion of compatible red blood cells into the fetus through a needle inserted into the mother's abdomen and into the umbilical cord that supplies the unborn child with its nutrients.

The team of OBGYN's and maternal foetal medicine specialists, doctors Clayon Kelly, Claudia Allen-Burton and Leo-Alexi Walker successfully conducted two transfusions two weeks ago at the hospital.

Dr. Walker highlighted the importance of these interventions in preventing severe cases of foetal anaemia. The first case was done at VJH in 2017 with the assistance of a maternal foetal medicine specialist from overseas. The 2019 case was done by local specialists as well as the two cases two weeks ago. The babies transfused in 2017 and 2019 are both well, and the recent transfused babies will be delivered next month.

Foetal anaemia is typically detected through specialised ultrasound scans, such as Doppler ultrasounds, which monitor blood flow and detect signs of anaemia. Although symptoms may not be apparent, severe cases can lead to complications like internal swelling, necessitating vigilant monitoring and timely medical intervention.



Capacity Building Workshop for Administrative Assistants

Mrs. Joan Nicholson-Walker, Director of Nursing Services at Kingston Public Hospital (KPH), spearheaded a highly productive capacity-building workshop for administrative assistants on July 30, 2024, at the National Chest Hospital.

The workshop, held under the theme "Unleashing Potential, Embracing the Change," focused on enhancing the skills and competencies of administrative assistants within the healthcare sector. Attendees engaged in a series of interactive sessions designed to improve their administrative capabilities, with a particular emphasis on efficiency, communication, and organizational skills.

The Sir John Golding Rehabilitation Centre (SJGRC), one of the specialist facilities managed by SERHA has been selected as one of the beneficiaries for the 11th Grennell Road Safety 5K Run, Walk, and Roll event, August 17, 2024. The Centre focuses on rehabilitating patients with spinal cord injuries, both traumatic and non-traumatic, offering 28 adult beds and 14 beds for children. Additionally, it operates outpatient services, including a general orthopedic clinic on Tuesdays and an artificial limb clinic on the first Fridays of each month.

Kingston and St. Andrew Health Services Marks World Mosquito Day 2024

The Kingston and St. Andrew Environmental Health Unit commemorated World Mosquito Day under the theme "Mek Mosquito Breeding Haad, Tek Back Yuh Yard," with a number of activities, including a march to sensitise residents about the impact of mosquitoes and the disease they cause on August 20, 2024.

STUDY LEAVE

Excerpts from the Staff Order for Public Service

7.8 2 SUPPORT FOR STUDY LEAVE

- I). Officers who are granted Study Leave may be eligible for financial support depending on the category within which the course of study falls.
- ii) Officers who are selected to pursue Government mandated courses of study (Category 1) would qualify for full financial support from public funds with no forfeiture of any accumulated vacation leave.
- iii) Officers who are selected to pursue job-related or future advancement courses of study Category 2 or 3 may receive the equivalent of up to two (2) years fully-paid leave. The officer would be required to forfeit leave or salary equivalent to his/her maximum leave accumulation. Any additional leave required to complete the course of study shall be without pay.
- Iv) Officers who are granted study leave to pursue courses of study under Category 4 may receive modest support, at the discretion of the Permanent Secretary or Head of Department.

7.8 3 BONDING

Bonding Officers who are granted study leave and receive support from public funds may be required to execute a loan agreement as outlined in sections 5.7 (iii - v), of these Orders.

7.8.4 DAY RELEASE

Officers may be granted a combination of day release during the academic year and full time study leave during the summer period to attend to attend any approved tertiary institution. This will only be considered where evening classes are not available for the particular course. The following conditions will apply:

i) The officer will cease to earn vacation leave at the commencement of the course until its completion.
