Reporting to the Parish Manager/ Chief Executive Officer, the **Chief Security Officer** (**GMG/SEG 1**) is a trained professional who is responsible for the institutions overall digital and physical protection by addressing important areas of security such as prevention, governance and investigation and to:

- ➤ Provide executive leadership and oversees the identification, assessment and prioritization of risks, directing all efforts concerned with the security of the Spanish Town Hospital and/St. Catherine Health Department:
- > To stay ahead of security issues, solve problems and ensure the entity runs smoothly.
- > Implement safeguards and reporting risk management mechanisms for regulation compliance.
- Leads security initiatives and heads the overall security strategy of the company.
- Perform security risk assessments and implementing security policies that prevent data loss and fraud
- Responds to new threats and upgrading security systems regularly are key aspects of this role.
- For the day-to-day governance of corporate security.
- Access authorization, identity checks and information systems protection.
- manages a security team that's responsible for securing the Hospital's and Health Department's

### MAIN DUTIES and RESPONSIBILITIES.

- Develops and implements a comprehensive security strategy
- Conducts risk assessments and identifying potential security threats
- Designs and implements security policies and procedures
- Oversees security operations and incident response
- Manages security teams and personnel
- Staying updated on emerging security threats and technologies
- Communicates security risks and recommendations to senior management
- Devises policies and procedures regarding areas such as business continuity planning, loss prevention and fraud prevention, and privacy.
- Oversees and coordinates security efforts across the organization, including information technology, human resources, communications, legal, facilities management and other groups.
- Identifies security initiatives and standards.
- Oversees network of managers who secure the company's assets.
- Oversees safeguarding of intellectual property and computer systems.
- Develops procedures to ensure physical safety of employees and visitors.

- Manages the development and implementation of security policy, standards, guidelines and procedures.
- Ensures security is maintained and updated.
- Implements video surveillance.
- Prioritizes security initiatives.
- · Develops network access and monitoring policies.
- Develops emergency procedures and incident responses.
- Investigates security breaches.
- · Implements disciplinary procedures.
- Conducts audits to find holes in security platform.
- Develops risk management assessments.
- Detects and analyzes risks involved with the organization to make sure there are no security vulnerabilities:
- > Uses equipment, such as information technology infrastructure and security software, to help further increase safety regulations:
- Responds to physical security incidents, such as trespassing:
- Develops innovative ways to secure the organization's data and assets.
- Develops and implement various security techniques and policies to decrease the risk of theft or exposure.
- Manages daily operations to ensure that the Hospital/ Health Department is secure.
- Implements safety strategies, such as asking employees to update their company login information.
- Meets with company executives or the security team to develop and implement daily safety standards.
- Helps with crisis management regularly, which is the response to disruptions and threats.
- · Any other related duties assigned by Parish Manager/Chief Executive Officer.

# MINIMUM QUALIFICATIONS and EXPERIENCE

- A bachelor's degree in a security-related field like criminal justice, cyber security, or a related field and a master's degree is often preferred.
- Certified Information Systems Security Professional (CISSP), Certified Protection Professional (CPP), or similar certifications.
- > Proven track record in security leadership roles, including experience in corporate security, law enforcement, military, or intelligence operations
- > Are expected to have advanced degrees in computer science, IT security, engineering or related disciplines.
- A master's degree in cyber security and at least five years of experience in a security management role would be an asset.

- > Substantial experience in security leadership roles,
- strong knowledge of security principles and practices,

- Deep understanding of security principles, practices, and methodologies like physical security, cyber security, risk management, crisis management, and compliance with relevant laws and regulations.

- Strong research competencies for risk mitigation and regulatory compliance. Analytical thinking and problem-solving skills for incident response and crisis management.
- Strong communication skills to deal effectively, both internal and external.
